From The Chairman

I'm short on space for my submission this time, so no sugar coating, here are the current issues before WAR from my view.

We had a GREAT meeting last July in Eau Claire, and finally got to meet some of the Minn. Coordination folk. They are trying to rework their bandplans to allow for some more ATV space. We have heard little from them since, so I don't know where this is.

In the last year, WAR has adopted some slight Bandplan changes, added the idea of 2 meter repeaters on 1 MHz Split pairs, and is now forwarding the idea of Coordinating Repeaters under 442 MHz (please see the past Newsletters). We need to inform, and or Lobby our neighbors to the south and west on these ideas, so all are on the same page. We're not alone here, RF doesn't stop at the State line.

Our neighbor to the east seems almost to not exist, we're having some difficulty getting responses back from our Coordination requests from Michigan, and to even some extent, from Minnesota. We basically assume their "Approved" after the 30 day response time elapses. But that is a LONG time to wait to get back to a Trustee to tell them they can go forward with building.

We also need to find some level of parity, and common sense with our Coordination neighbors. For example, the MACC 120 mile spacing for 2 meters is a good general rule, but was made long ago, and is simply arbitrary. With accurate data, and the software tools we have in hand today, there are many situations that the RF model proves that 120 mile separation is not necessary. We have had proposals rejected by other Coordinators at 118 miles for example. It's 2003!

We also should be looking at a new or better way of looking for available pairs along our borders. RF knows no boundaries, and all HAMS have the right to the Amateur Spectrum. If a machine is removed from operation in one state, that does not immediately mean that state has the first go at a new coordination. To be blunt, the pair should not be reserved or "held in our back pocket".

I was at a swapfest recently where I was personally ripped a new orifice from some trustees who wanted to know "Who made

you God", "Why do we have to spend all this time each year filling out forms" etc. Helllo? WAR is volunteers, thanks for your support. Without current, accurate information, WAR is worthless.

I believe we have evaluated and revised the renewal system over the last few years to be VERY EASY for the trustees. If you don't agree, please get to me or Dave and let us know. Please just look at the paper we send out, check its accuracy, and mail it back to Milt. The 10 minutes it will take are really in your best interest,

Coordination IS entirely voluntary. I really don't care if someone wants to operate an uncoordinated repeater. They have every right to do so, however with no visibility or knowledge of it, WAR may place something over the top of them, and unfortunately for them, the FCC is going to side with the majority that recognize the coordination process. In any interference issue, the FCC has consistently sided with the trustee of the coordinated system(s).

Coordination IS really cooperation. Respect for your fellow HAMS, and the Amateur Radio Service. WAR has been an active coordinator since the 70's, and it's "power" comes from its members.

Our next meeting will be in Appleton, and will be the election of Officers for 2003. Come vote "god" out of office... please!

ARES / RACES Designations

The listing of ARES/RACES affiliation in the WAR database is beneficial for those who try to find such a repeater by reviewing WAR publications, or the ARRL repeater directory. Currently, there is no criteria, or confirmation that a particular repeater is an ARES/RACES ARRL affiliated machine, beyond the fact that someone checked off a box on the WAR renewal from.

This issue has been brought to WAR's attention by several EC's, and Stan WB9RQR the State SEC. Deciding what may be an ARES/RACES repeater is difficult. For example, in Outagamie and Milwaukee Counties, ARES/RACES has operating agreements with many of the local repeaters in these areas. Does this mean they all should be designated ARES/RACES repeaters? They could be. In Milwaukee County, only one repeater is actually owned by ARES/RACES itself, should this therefore be the only ARES/RACES machine listed?

This is obviously an ARES/RACES issue, and not technically part of WAR's required data (LAT, LON, ERP, etc.) needed to coordinate a frequency pair. However WAR's database does include this data, and WAR does have a greater responsibility that any of the data we provide back to the Amateur Radio Community, and to the ARRL for use in the Repeater Directory is accurate to the best of our ability. WAR provides many "value-added" services beyond Coordination, such as our newsletter, and www site.

After some discussion with the State SEC, Stan WB9RQR, it is apparent that the only person(s) capable of knowing, and making the decision of which local repeater(s) is in fact an ARES/RACES machine, is the local County EC.

Therefore at our next meeting, WAR will consider adopting a Policy that "The designation of an ARES/RACES affiliated Repeater must have the approval of the local County ARES/RACES EC and/or State SEC."

This would mean all current ARES/RACES flags must be removed from the WAR database. A letter would be generated to each county's ARES/RACES EC asking for their input. A letter will also be sent to all current ARES/RACES flagged trustees informing them, and urging them to contact their local County EC to resolve this issue.

A matter of priorities

It seems that no matter how much I promise to stay on top of things, there is always a competing number one priority. Some may have noticed a lack of my usual commentary in the last newsletter. Why? Well I missed Gary's publication deadline.

I think for the most part, all coordination's that contained no omissions or errors have been handled in a timely manner. There are a few here that sat for a while because I had questions for those that submitted them, I had sent out an inquiry, but never received a response, and frankly I didn't expend the energy to hound the folks that had submitted them.

De-coordination's

I've also been slow in sending out decoordination letters. Throughout the year I've received various input from others as to machines that seem to no longer exist. In general I'll make a notation in the file, and follow up on the matter at a later date. If I happen to be in the area, I'll make an effort to see for myself if the machine is on the air or sometimes will even visit the site to see whether any antenna's still exist. Sometimes a letter returned by the post office, or a crosscheck of the ULS database provides our first notice that a repeater owner has moved out of town.

I want to be clear that I'm not proactively policing anyone's repeater, I've got enough to do without trying to create more work.

My point in mentioning all of this is to remind you that I very much appreciate those who are pro-active in working with me and are up front about what's going on with their repeaters.

I've got a small group of systems that are in our database but are not being published because the system owner's have been up front about their system(s) not being on the air, but with intentions of repairing them at some point in the future.

Now before you cry "foul", I would point out that these systems exist in less populated areas of the state where there are other frequency pairs available. By keeping them in the database, I avoid the potential of re-assigning that particular pair to someone else, and yet it keeps the published repeater directory updated with only those systems we believe to currently be viable operations.

Renewals

Speaking of priorities... The Spring 2002 renewals finally went out in mid-November.

This latest batch of renewals resulted in about 200 envelopes being sent to the primary contacts for about 300 database entries with update dates prior to November 2001. This was also the first batch of renewals that Milt, N9WSZ, processed. While Milt and I still have some bugs to work out of the process, it was a welcome relief to be able to spread some of the administrative workload around.

Thank you Milt!

Unfortunately, it seems that even though we now have implemented a proactive renewal process where we are able to share with you the data we currently have on file, the list of those we received no response from is quite large.

Elsewhere in the newsletter you will find a list of repeaters we received no response from. I believe I have edited out all the systems that have either contacted me and indicated I will see their paperwork very soon, or in a couple instances where we've had letters returned to us and are in the process of sending them back out to a different contact person.

A second mailing is being generated to those system owners on the no response list. If we don't receive a response this time around within a few weeks, you will be receiving a third letter.

You don't want to receive the third letter.

Shortly after this second notice mailing, I will also generate renewal letters for those with the last update dates in the November 2001 through April 2002 time frame, and this should ultimately bring everyone's renewal cycle up to date until the Spring of 2004.

On the coordination front...

Over the past few years I've worked hard to never have to say "NO", but try as I might, sometimes there just seems to be no alternative.

In a few instances I've been able to negotiate some frequency changes between repeater owners to allow another repeater to be placed on the air, or to resolve an ongoing interference problem. I'm quite pleased to say that in all but two instances, everyone has been very cooperative and willing to do whatever it takes for the betterment of the hobby.

I also very much appreciate the help and cooperation we've received from the coordinators in adjacent states.

I want to express my sincerest appreciation for those that recognize the no single person owns a given channel, and that we all share this multi-billion dollar resource equally. Thank you.
