From the Assistant Coordinator

Thus far in 2013 we have handled 23 coordination requests. These requests added 12 new repeaters, 1 new D-Star repeater, 1 new P25 repeater, 2 new links and changes to 7 repeaters. There are 13 coordination requests that are currently being processed.

On May 13th I mailed 184 renewal forms for 2013. These were due back August 15th; 79% were returned. On September 3rd 39 second notice renewal forms were mailed that are due back by November 15th. The list of repeaters whose renewals have not been returned as of October 19th is listed in the this newsletter. If renewals are not returned by November 15th the repeater is subject to de-coordination.

De-Coordination Notice

The following repeaters are subject to de-coordination for not returning the 2012 renewal form.

They may request re-coordination in person, or by proxy, at the November 16th WAR meeting in Appleton, WI.

N0BZZ 146.700 Bayfield N0BZZ 443.850 Bayfield KC9FWD 147.285 Wautoma Note that renewal forms are sent for operational repeaters only. If you feel you should have gotten a renewal form, maybe you forgot to let us know when your repeater went on-the-air.

When you contact W.A.R. regarding a repeater,s coordination, please identify the repeater by callsign, output frequency and city. That ensures we,re both talking about the same repeater, and lets us quickly find the repeater in the database (which has 365 repeaters and 220 links). Identifying your repeater by a club name or a portion of the frequency (e.g., 67) is insufficient. Also, there is no way to search the database based on a club name. I,ve received emails/letters that talk about "my UHF" or "my D-Star" repeater, or just a frequency and no city or callsign; these emails/letters were signed with a first name only and no callsign. That makes it pretty difficult to find the data needed to answer your question. Please help me to help you. Remember that we're all volunteers trying our best to help you.

At times Dave Karr (frequency coordinator) or I will send an e-mail to you with the other copied on it. When you go to reply please do a "reply all", not just a simple "reply". We,ve copied each other because we need the other to see your response so that further action on your coordination request can be taken. A simple reply, does not accomplish that because then your reply e-mail goes only to the sender, and the other person copied on the original e-mail never receives your reply.

Remember that coordinations are to be requested BEFORE any changes are done on a repeater system.

Assistant Coordinator's Report - Milt 35 coordination requests. There was an explanation of the handling of the process. 181 renewals sent out in May. In August 22 second notices were sent. There was discussion about a change of coordination with a repeater in Wautoma. Still waiting for them to appointment the new contact person. Clubs should be listed as the owner of coordination. can then change the trustee as they feel. Officer of the club can make the request of callsign change. Primary contact needs to be a person and the secondary should be the club.

N9QIP asked a question about a Tone change and not being available in the listing until the coordination and status has been processed. Any changes to a system are sent out to the other states coordinators. Coordination process explained by Milt. Milt needs Coordination the constructed information back from the repeater owner. We do not share the database info with just anyone. Only the other coordinators share our database.

W9RMA has an issue with the new coordination of interference of his new KB9LUK 147.210 repeater. PL173.8 pl on the repeater. He asked for asked for a different frequency of the 146.805 MHz. Discussion of the coordination reason for the frequency. We use models for mobile users not base stations. A discussion of a PL tone plan.

145.110 packet repeater in Minnesota interfering with N9QWH repeater in Earl for 10 years. Minnesota Repeater Coordination group has this listed as a digital repeater. Dave KA9FUR will ask MRC about this coordination.

Discussion on shared non protected being coordination by MRC. groups have not standardize on the shared frequency.

Coordinator's Report – Dave KA9FUR No report.

New Business

Someone stated that 146.550 seems to have repeater on it. This is a simplex frequency and WAR does not coordinate simplex frequencies. comment was made that it could be a someone using a cross band radio.
