Coordination Secretary's Report: 10:06 CDT

- Corey, KB9BNA gave a presentation on the Coordination Secretary role created by the board in September, 2017.
- Seven steps towards coordination
  - Receive request forms via USPS or email
  - Coordination Secretary stages request to CTK database
  - Frequency Coordinator proposes coordination
  - Frequency Coordinator sends NOPC (Notice of Proposed Coordination) to adjacent states

- Frequency Coordinator/Secretary waits for NOPC waiting period then generates letter of coordination
- Station owner is given 6 months to place station on-air as coordinated
- Owner updates Coordination Secretary when station is operating on-air as coordinated
