Coordination Secretary's Report

- Coordination Activity since August meeting...
 - 11 new coordinations issued
 - 2 operating modifications to existing coordinations
 - 25 responses to adjacent state NOPC's
 - 8 current open coordinations (in various states)
 - 19 coordinations in construction status
 - Please let us know of updates
 - After 6 months they can be de-coordinated
 - Keep us up-to-date and we can extend
 - Just keep communication open
 - 14 coordinations awaiting NOPC's / ready to issue
- Annual Updates
 - We were a little behind last year focused on coordinations
 - Now we're a little behind on coordinations as we finish up the annual updates
 - Had a really good response on the 1st round of annual updates
 - Will be getting the repeater list updated on the website in the near future

President's Report

- Annual Notices
 - 1st notices were sent in November 2018
 - 2nd notices were sent in February 2019
 - There are some we haven't received a response too will be reaching out to known contacts for repeater
- Adjacent States Audio Conference
 - Held in January 2019
 - Discussed better coordination with sharing information
 - Sharing databases between states on a regular basis
 - Discussed possibly moving away from CTK
 - Been some dissatisfaction with CTK software
 - Looking at possible other solutions, some online based
 - Moving to an online platform would allow us to look at better integration and automation

Old Business

- Band Plan
 - Appreciate getting updated band plan out
 - Can continue discussion of band plan and update as needed
 - We're not going back and forcing existing coordinations to match current band plan
 - Band plan is to provide guidance moving forward
 - Look at providing specific recommendations on simplex frequencies
 - Today's operators may not fully understand the guide
 - Board to add to the FAQ on specific recommendations for hotspots
- Repeater Listings
 - Only officially on WAR website
 - No longer submitted to ARRL, they don't even except submissions

New Business

- Inaccuracies in Repeater Coordinations
 - There was a period of time a few years back where we had people helping with inputting coordinations

TERS, INC.

- Repeater location, power output...items not entered correctly
- We can try and go back and see when information may have changed
- Please let us know of incorrect reporting and we can dig into this
- Adjacent State Coordinations Entering NOPC's into CTK
 - NOPC doesn't guarantee coordination
 - We also don't get notices on de-coordination
 - Need to rely on sharing databases between states for accuracy
- Meeting Notices
 - Notice was posted to website and facebook
 - Membership request email notification 30 days prior to meeting
